³⁾ NB: A fee of EUR 35 (DKK 260) shall be charged for countries with which the European Commission has concluded or is negotiating a visa facilitation agreement.

⁴⁾ Where several documents are issued together to the citizen, a total fee of DKK 310 shall be charged. However, for handout of passport, it will be charged per piece.

⁵⁾ Provided the request for VAT refund comprises several separate purchases, a fee of DKK 245 shall be charged per statement.

⁶⁾ Where several provisional passports or extensions of passports are issued at the same time, a fee of DKK 2,870 shall be charged for the first passport and DKK 1,230 or DKK 1,789 for subsequent passports.

⁷⁾ Where several provisional passports or extensions of passports are issued at the same time, a fee of DKK 4,100 shall be charged for the first passport and DKK 1,230 or DKK 1,789 for subsequent passports.

⁸⁾ The fee may increase to EUR 135 or EUR 180 if an implementation decisions has been adopted in the EU in accordance with the Visa Code Article 25a. Does not apply to children up to and including eleven years of age.
