⁵⁾ Provided the request for VAT refund comprises several separate purchases, a fee of DKK 225 shall be charged per statement.

⁶⁾ Where several provisional passports or extensions of passports are issued at the same time, a fee of DKK 2,625 shall be charged for the first passport and DKK 1,125 or DKK 1,780 for subsequent passports.

⁷⁾ Where several provisional passports or extensions of passports are issued at the same time, a fee of DKK 3,750 shall be charged for the first passport and DKK 1,125 or DKK 1,780 for subsequent passports.
